# Playgroup NSW Welcomes NSW Government's Strengthened Working With Children Check Legislation

Playgroup NSW applauds the NSW Government's recent introduction of legislation to strengthen Working With Children Checks (WWCC), a significant step forward in safeguarding children across our state.

These comprehensive reforms — placing oversight solely with the independent Office of the Children's Guardian (OCG), removing appeal routes through NCAT, and pushing for a searchable national WWCC register demonstrate a robust commitment to making child safety a legislative and operational priority.

"At Playgroup NSW, we wholeheartedly support these critical reforms and thank Minister Kate Washington for her leadership in driving safety for our children, as well as protecting those working in our sector doing the right thing." said Emily Caska, CEO of Playgroup NSW.

"Our 80+ staff and more than 500 volunteers deliver programs across NSW and ACT, working hand-in-hand with our 72,000 families and children to promote early learning, community connection, peer support and, above all, children's safety. As one of the largest playgroup and peer support entities in Australia, we welcome more rigour to ensure that all children thrive and are safe in the first 2,000 days."

We reiterate our firm stand as reflected in our Statement of Commitment to Child Safety released at NSW Parliament House in March this year for National Playgroup Week, which centres the rights, wellbeing and empowerment of children in all our programs, guided by both the United Nations Convention on the Rights of the Child and the National Principles for Child Safe Organisations.

"These reforms align strongly with our values," Emily continued. "We look forward to working with the NSW Government and all jurisdictions across Australia to continue advancing national harmonisation of WWCC systems, to ensure consistent, rigorous protection for children, wherever they live, move or play."

Playgroup NSW remains dedicated to working collaboratively with government bodies, community partners and early childhood services to support the rollout of these reforms and help deliver a safer national framework for working with children.
